It applies to information technology contained in both business systems and national security systems (except as noted) developed for or purchased by the Department of Army. It addresses the management of information as an Army resource, the technology supporting information requirements, and the resources supporting information technology. This regulation implements 40 United States Code, Subtitle III; 44 United States Code, Chapters 35 and 36; 10 United States Code, Sections 2223 and 3014; and DODD 8000. 01. It establishes the Armys Chief Information Officer. The full scope of the Chief Information Officers responsibilities and management processes are delineated throughout this regulation. These management processes involve strategic planning, capital planning, business process analysis and improvement, assessment of proposed systems, information resource management (to include investment strategy), performance measurements, acquisition, and training.
